- Any remaining vehicles, large or small, will not be able to leave the grounds until after the end of the event at 7:00pm

# **IMPORTANT: THE FINE PRINT**

- A. COMPLETED APPLICATIONS & PAYMENTS ARE DUE BY August 18, 2023.
- B. The Plainfield Business Association reserves the right to make all final decisions regarding vendor participation and the location of the vendors.
- C. This registration form becomes the leasing contract between the Sponsor/Vendor and the Plainfield Business Association, which is the "Management," and is subject to all terms and conditions outlined in the TERMS AND CONDITIONS of this form.
- D. Current PBA members whose annual dues have been paid for 2023 are already sponsors for the event and may choose a 10x10 vendor spot **OR** a banner (included with the \$100 membership dues). We still require that a sponsor application to be filled out and submitted by the deadline of September 1, 2023.

### **TERMS AND CONDITIONS**

#### 1. USE OF SPACE:

- **A.** Liability The Sponsor is entirely responsible for their vendor spot.
- **B.** Aisles The aisles remain strictly under control of management, and no signs, decorations, promotional materials, will be permitted except by special written permission of the Management. All exhibits and their personnel must remain within the confines of their own space and no Sponsor will be permitted to erect signs or display products in such a manner as to obstruct the view of other Sponsors. No interference with the space of another Sponsor will be permitted.
- **C. Space** The space contracted is to be used solely for the Sponsor whose name appears on the Contract, and it is agreed that Sponsors will not assign any portion of the same space without the written consent of Management. In the event the Sponsor, having requested a vendor space, fails to occupy or use their vendor space or have their exhibit completed and in place before the deadline on Saturday, September 16 at 9:30am, the Sponsor will forfeit all rights to that space.

#### 2. RULES FOR SPONSORS:

- **A. Vendor Space** All tents, materials for space decorations, tables and chairs are the responsibility of the Sponsor.
- **B.** Installation Any special carpentry, wiring, electrical, gas, or water shall be installed at Sponsor's expense.
- **C.** Vehicles All sponsor vehicles must be off the track before 9:30am. (deadline for setup).
- **D.** Licenses Any and all Municipal licenses, permits and/or inspections required by law of any Sponsor shall be obtained by the Sponsor at its own expense prior to the opening of the event.
- **E. Rights of Management** Celebrate Plainfield Day is a rain or shine event. In cases of severe weather, Management reserves the right to interrupt or cancel the event in the interest of public safety. Management shall not be liable for any damages or expense incurred by any Sponsor in the event that Celebrate Plainfield Day is delayed, interrupted, or not held as scheduled.

- **3. SECURITY** The Plainfield Business Association wishes to provide a safe event. Management is not financially liable for the losses or disappearance of property of any kind. We recommend that you contact your insurance company to confirm proper coverage of exhibit materials. The Plainfield Business Association is not responsible for items left unattended at the event.
- **4. LIABILITY** Management will not be responsible for any injury, loss, or damage that may occur to the Sponsor, the Sponsor's employee, or property thereof, from any cause whatsoever. If the Sponsor is requesting a vendor space, a Certificate of Insurance must be provided along with the Registration Form.
- **5. PAYMENT** Sponsorships must be paid in full along with Sponsor's completed Registration Form no later than September 1, 2023.
- 6. CANCELLATION If the Sponsor requests a vendor spot and is unable to occupy it for any reason and does not choose to display a banner at the event instead; cancellation must be made in writing to the Plainfield Business Association, no later than September 1, 2023. All cancellations are subject to a \$25.00 cancellation fee. Refunds will be available after September 23, 2023. No verbal cancellations will be accepted.

Celebrate Plainfield Day is a rain or shine event. In cases of severe weather, Management reserves the right to interrupt or cancel the event in the interest of public safety. No refunds will be issued; however, Management will compensate for the Sponsor's investment through promotional exposure on the PBA website and Facebook page.
